

## Macquarie Harbour Marine Farm Lease Visual Compliance Results, May 2018



Marine Farming Licence Conditions relating to environmental management of finfish farms in Macquarie Harbour require compliance with environmental standards. One requirement is that there must be no significant visual impacts at, or extending beyond, 35 metres from the boundary of the lease area.

Visual impacts from farming outside of marine farm lease areas are monitored by remotely operated vehicles with cameras surveying for benthic bacterial mats (*Beggiatoa spp.*) at compliance points located around lease areas at 35 metres from the boundary of the lease. Where *Beggiatoa* is detected at these points, additional +50m dives are conducted to map the extent of *Beggiatoa*. Results tabulated below are limited to 35 metre compliance points.

In the event that a significant visual impact is detected at any point 35 metres or more from the lease boundary, the licence holder may be required to undertake a triggered environmental survey or other remedial activity determined by the Director.
