Your personal information will be used for the primary purpose for which it is collected and may be disclosed to the contractors and agents of the EPA, law enforcement agencies, courts and other organisations authorised to collect it.

Your basic personal information may be disclosed to other public sector bodies where necessary for the efficient storage and use of the information.

Personal information will be managed in accordance with the *Personal Information Protection Act 2004* and the *Right to Information Act 2009* and may be accessed by the individual to whom it relates on request to the Environment Protection Authority. You may be charged a fee for this service.
